**SNOWBIKE RENTAL RELEASE OF LIABILITY**

- PLEASE READ CAREFULLY BEFORE SIGNING THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS
- The undersigned, being of at least 18 years old or that if he/she is younger than 18 years of age, is accompanied by a parent or guardian, who has read and signed the following release (hereinafter referred to collectively as "I").
  - I accept for use "as is" the Snowbike equipment listed on this form and accept full responsibility for the care of the equipment while it is in my possession.
  - I will be responsible for the replacement at full retail value of any equipment rented under this form, which is not returned to the shop, and I acknowledge my obligation to return this equipment by the agreed date in clean condition to avoid any additional charges.
  - I agree and understand that snowbiking is a HAZARDOUS activity (hereinafter "Activity"). Further I recognize that there are risks including, but not limited to, all of the inherent risks of skiing as provided below. I recognize that injuries are a common and ordinary occurrence of the Activity. I hereby agree to freely and expressly assume and accept any and all risks of injury or death to the Participant/Purchaser/Renter while participating in the Activity. Nonetheless, the Participant/Purchaser/Renter voluntarily elects to participate in the aforementioned Activity.
  - I UNDERSTAND AND RECOGNIZE THAT I AM A SKIER WHILE ENGAGING IN THIS ACTIVITY and therefore am subject to the inherent dangers and risks of skiing. Under Colorado law, a skier assumes the risk of any injury to person or property resulting from any of the inherent dangers and risks of skiing, including: Changing weather conditions; existing and changing snow conditions; bare spots; rocks; stumps; trees; collisions with natural objects, man-made objects, or other skiers; variations in terrain; and the failure of skiers to ski within their own abilities.
  - I hereby assume all risks which may be associated with and/or result from my involvement in such Activity and release and indemnify the renting and/or providing agency and Front Range Snowbikes, its subsidiaries and affiliates, their respective officers, directors, agents, servants, and employees (hereinafter "the shop"), of and from any liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage or injury, including death, that may be sustained by me while participating in the Activity, including but not limited to, those injuries and damages caused by the negligence and/or breach of warranty, expressed or implied, on the part of the shop.
  - By execution of this release the shop shall be indemnified for any injury to other person(s) or property, which I may cause as a result of engaging in this Activity.
  - I have made no misrepresentation to the renting or providing organization with regard to any information which it has requested of me related to rental and/or my use of the equipment.
  - I acknowledge that I will be the only person using the Snowbike equipment during this rental period.
  - All instructions on the use of the equipment have been made clear to me and I understand the function of my equipment.
  - I CONTRACTUALLY AGREE that ANY AND ALL DISPUTES between the shop and myself arising from my use of this equipment and/or participation in the Activity OR use of this equipment, and INCLUDING any claims for personal injury and/or death, will be GOVERNED BY THE LAWS OF THE STATE OF COLORADO and EXCLUSIVE JURISDICTION thereof will be in the state of Colorado residing in the county where the alleged tort occurred or the Federal Courts of the State of Colorado.
  - IN THE EVENT THAT ANY SECTION OF THIS RELEASE IS FOUND TO BE UNENFORCEABLE, THE REMAINING TERMS SHALL BE FULLY ENFORCEABLE.
  - THIS RELEASE SHALL BE BINDING TO THE FULLEST EXTENT PERMITTED BY LAW.
  - This release shall be binding upon my assignees, distributors, heirs, next of kin, executors, personal representatives, and administrators and may be pled by the shop as a complete bar and defense against any claim, demand, action or causes of action by or on behalf of the Participant/Purchaser/Renter.
